

PLEASE READ LABEL COMPLETELY BEFORE USE

HANDLING PRECAUTIONS: Causes skin irritation. Causes serious eve damage. Avoid contact with skin and eyes. Wear eye and face protection. Cyromazine may possibly affect blood and the haemopoietic system. Acetic acid possibly may damage lungs following inhalation. Do not breath fumes, vapours and spray, Handle with care. Wash hands and exposed skin before meals and after work.

FIRST AID: If medical advice is needed, have product container or label on hand. IF ON SKIN: Wash with plenty of soap and water. If skin irritation occurs: Get medical advice/attention. Take off contaminated clothing and wash before re-use. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. For advice, contact a doctor or the National Poisons Centre 0800 POISON (0800 764 766) immediately.

EMERGENCY RESPONSE: In case of spillage, wear appropriate protective clothing and prevent material from entering waterways. Absorb spills with inert material and place in waste containers. Wash area with water and absorb with further inert material. Dispose of waste safely.

DISPOSAL: Preferably, dispose of product by use. Otherwise, dispose of product and packaging at an approved landfill or other approved facility. Triple rinse container and dispose of rinsate away from waterways. Burn in an appropriated incinerator, if circumstances such as wind direction permit, otherwise crush or punture and bury in a suitable landfill.

GENERAL INFORMATION: Unlock Cyromazine Spray-On is an easy use spray-on that will give residual protection against flystrike caused by all the commonly found strike flies including the Australian blowfly (Lucilia cuprina) for up to 8 weeks. Unlock Cyromazine Spray-On is to be used only on coarse woolled breeds of sheep. Unlock Cyromazine Spray-On is suitable for use on sheep between 4 and 12 weeks after shearing. The period of protection may be reduced by incorrect application; excessive fleece soiling; heavy fleece conditioning; if infections such as mycotic dermatitis (fleece rot) are present; or if prolonged heavy rain occurs following application.

DIRECTIONS FOR USE - SHAKE GENTLY BEFORE USE

By law, the user must take due care, seeking expert advice if necessary, to avoid unnecessary pain or distress when using the product in a manner other than as recommended on the label.

Apply Unlock Cyromazine Spray-On through a suitable clean applicator gun. The product should be sprayed on in bands with the gun held 20cm above the wool during application. Unlock Cyromazine Spray-On should be applied onto those areas where maximum protection against flystrike is required.

Unlock Cyromazine Spray-On applied between the rump and shoulders should be sprayed on in even bands as shown (see diagram). The product sprayed onto the rump should be applied in an arc over the area shown (see diagram). The dose rate and number of bands to be applied are shown in the table. Note: The dose volume should be based on weight of the heaviest sheep in the mob.

Application and dose rate of Unlock Cyromazine Spray-On for the protection of all the commonly struck areas of the sheep (Table A).



Application and dose rate of Unlock Cyromazine Spray-On at docking for prevention of flystrike. Apply between 5 & 10mL over the crutch ensuring that sufficient product to cover the area to be protected is applied.

WITHHOLDING PERIODS

MEAT: Sheep producing meat and offal for human consumption must not be sold for slaugher either during treatment or within 21 days of the last treatment.

MILK: Milk intended for sale for human consumption must be discarded during treatment and for 35 days following the last treatment.

Wool Residues: Ensure the time between dipping and subsequent shearing is at least two months, except in the case of spot treatment of flystrike. For advice on your dipping programme, contact your supplier.
